LG PC/LAPTOP COMPUTER LIMITED WARRANTY – U.S.A

Should your LG PC/Laptop (“**Product**”) fail due to a defect in materials or workmanship under normal and proper use, during the warranty period set forth below, LG Electronics (“**LG**”) will, at its option, repair or replace the Product. This limited warranty is valid only to the original retail purchaser of the Product and applies only when purchased and used within the United States including U.S. Territories

LIMITED WARRANTY PERIOD

Labor: One (1) Year from the date of original retail purchase.

Parts (Excluding Battery): One (1) Year from the date of original retail purchase (internal / functional parts only)

Battery: One (1) Year from the date of original retail purchase

Replacement products and parts are warranted for the remaining portion of the original warranty period or ninety (90) days, whichever is greater.

Replacement products and parts may be new, reconditioned, refurbished, or otherwise factory remanufactured.

Replaced products or parts will be the property of LG.

HOW SERVICE IS HANDLED

The sales receipt specifying the Product and date of original retail purchase is required to obtain warranty service.

In the event of absent valid POP, the limited warranty period for the Product shall extend for fifteen (15) months from date of manufacture as determined by the Product’s manufacture date code.

You shall bear in-bound shipping costs (including shipping damage or loss) of the Product to LG or its designated repair center for service. LG shall bear return shipping costs of the Product back to you after completion of service under this limited warranty.

- Loss or damage of confidential, proprietary, or personal information contained on the Product at time of service.
- Loss or damage of any corrupted or removable media data.
- Damage or defects of the Product caused by transportation and/or handling, including scratches, dents, chips, and/or other damage to the finish of your Product, unless such damage results from defects in materials or workmanship and is reported within one (1) week of delivery (Call: 1-800-243-0000).
- Damage or defects of the Product caused by use of accessories, components, or consumable cleaning products that are not approved by LG.
- Products with original serial numbers that have been removed, altered, or cannot be readily determined.
- Products sold or labeled as “as-is,” “where is,” or similar disclaimer.

- Failure of customer to notify LG of the alleged defect or malfunction of the Product during the applicable limited warranty period.
- Increases in utility cost and additional utility expenses.
- Replacement of any consumable parts.

The cost of repair or replacement under the above excluded circumstances shall be borne by you.
